ACEI President's Opening Address

I was deeply honoured to have been elected as President of the Association of Consulting Engineers of Ireland by you, the members, at our recent AGM. I am the 60th President of the ACEI and the 5th member of the Garland family to be honoured with the role and I hope I will live up to their extremely high standards.

At the outset, I want to thank our outgoing President David McHugh for his work over the last number of years as a member of executive, officer and president.

As you are all aware, the members of executive and committees give tirelessly of their time and expertise, for which my thanks are due. The ACEI is always looking for others to assist with various committees, so if a call does come, please do look favourably on the request.

The executive, with the assistance of the secretariat, is continuing with many recent initiatives on behalf of members. One key focus for this year will be the implementation of the recommendations of the "Bridging the Gap" report, which was shared with you last month. We will also continue to focus on supporting members in the Pledge to Net Zero. With the help of the secretariat and executive, I also intend to grow the membership of the Association by 20% from the current level of 102 member firms.

Arising from the announcement last week, I want to congratulate the companies who had projects shortlisted for the ACEI 2022 Annual Engineering Excellence Awards. Although many applications were received overall, we were disappointed to note the comparatively low number of entries in the Project Management category. As this is an area of expertise that engineers traditionally excel in, I would encourage all members to look for projects to enter in next year's Project Management award.

We are due to meet with the Department of Agriculture this week on the issues of forestry and timber supply. The lack of supply of domestic timber has led to a doubling of the price of timber and is affecting the delivery of housing. I was shocked to learn recently that planting is currently at its lowest level since 1946. This is just one of many engagements the Association undertakes with stakeholders on your behalf. In 2021 we met or interacted with 15 different organisations on a total of 27 occasions.
