



PRIVACY NOTICE

At ACEI we regard your data protection rights as extremely important and we treat them accordingly. This Notice sets out how we collect and process your personal data and tells you what your rights are about the way we process your personal data. Please read below for details.

1. Who are we? How can you contact us?

"We" are the Association of Consulting Engineers of Ireland ("ACEI"), which is a voluntary, self-regulatory body representing the building and professional interests of firms and individuals engaged in Consulting Engineering. We are a company limited by guarantee registered at the Companies Office with company no 16499.

The **DATA CONTROLLER** for the purposes of the General Data Protection Regulation EU2016/679, and the Data Protection Acts 1988 – 2018 is "The Association of Consulting Engineers of Ireland".

2. What information about me do you collect & use? And Where do we get your personal data from?

We collect Personal Data from you which you volunteer when you provide such Personal Data to us, or via our services with which you interact. We may also be given other Personal Data relating to you by other persons, or we may obtain such other Personal Data about you as may be provided to us in the course of our legitimate business activities.

We may collect and process Data, including the following in the course of providing services to you, which could contain your personal data may include your special category data:

"Personal data" is data identifying you, either directly or indirectly, as an identified or identifiable individual.

When you engage with us via the website, or by letter, telephone or personally, we collect personal data in accordance with the law, such as your name, address, contact details and purpose of your enquiry or concern.

We also collect data directly from you when you or your firm become a member of the ACEI.

The personal data we collect includes:

- your full name;
- address;
- work address:
- email addresses;
- home and work phone numbers;
- mobile numbers;
- membership of professional institutes, associations or bodies;
- Qualifications;
- Year of obtaining qualifications;
- Status in employers firm;
- Length of time in role;
- financial information about you, including:
 - your bank account details
 - o credit card details, and
 - other payment details

- any other data which you ask us to process on your behalf, or which is necessary for us to process in order to fulfil our role in providing membership services to you, including:
 - o seminars
 - o training courses, etc.
 - o Images, sound and video data from CCTV recorded seminars and award events.

In certain circumstance we also collect some special category categories of data such as:

- health information in relation to employees during the course of employment;
- health data which is necessary for us to have to provide a superior and safe service to you, for example, at courses, that you suffer from reduced mobility or have special dietary or other requirements which are health related.

We may also process other data, which is not personal data.

When you access our website your device's browser provides us with information such as your IP address, browser type, access time and referring URL which is collected and used to compile statistical data. This information may be used to help us to improve our website and the services we offer, and to offer services to you.

We can sometimes obtain personal information that you post on social media, such as LinkedIn, Twitter, Facebook etc. Please keep in mind that if you directly disclose personal information or sensitive data through social media, this information may be collected and used by others. We have no control over such social media websites, and this Privacy Notice does not apply to such data. You should consult each site's Privacy Notice for information about their processing.

3. Do you collect personal from children (under 16yr olds)?

Our services are not directed to children under the age of 16 years and we request that such individuals do not provide personal data to us.

We do NOT collect any data from children and if we discover that we inadvertently have such data we will immediately delete it.

4. How and why do you use my personal data?

We will process your personal data for the purposes as set out in this Notice, in particular:

- To provide to you our full range of membership services;
- Carry out any contractual obligations we have towards you;
- To promote and organise our profession and the business and interests of our members;
- To operate the ACEI website and deliver the response or service you have requested;
- To inform you of other products or services available from ACEI and its affiliates;
- To contact you directly or via surveys to conduct research about your opinion of our existing services or possible new offerings that we may be considering;

- To contact you on behalf of other business partners about offers or services we believe may be of interest to you (we will not disclose your personal data without your consent);
- In addition, ACEI share data with trusted suppliers in order to assist us operate our business, provide member support, provide computer and other services to us, to provide security services to us, to perform statistical analysis, to contact you via email or by post and to arrange for deliveries. All such third parties are prohibited from using your personal information except to provide these services to ACEI, and they are required to maintain the confidentiality of your information;
- We will also process your data to comply with any legal obligation we have, and to obey any Court Order.

5. Do you share my personal data?

Your personal data is shared as necessary within ACEI, for membership purposes such as internal administration, invoicing, event and services promotion, providing you, your organisation or company with our services and also as set out below.

We do not sell, rent, or otherwise share personal data with unaffiliated entities for their independent use except as expressly described in this Privacy Notice.

We share data with our third-party service providers that perform services on our behalf, such as web-hosting companies, mailing vendors, analytics providers, event hosting services, information technology providers, cloud storage providers.

We would also share with service providers, advisors, potential transactional partners, or other third parties in connection with the consideration, negotiation, or completion of a transaction in which we are acquired by or merged with another company or association, or we sell, liquidate, or transfer all or a portion of our assets.

Such sharing takes place only to the extent necessary to perform the services carried out for or on our behalf, and making sure that they comply with data protection law.

All such third parties are prohibited from using your personal information except to provide these services to ACEI and they are required to maintain the confidentiality of your information.

ACEI will otherwise disclose your personal information, without notice to you, only if required to do so by law or in the good faith belief that such action is necessary to:

- (a) conform to the edicts of the law or comply with legal process served on ACEI or the website;
- (b) protect and defend the rights or property of ACEI and its staff; and,
- (c) act under exigent circumstances to protect the personal safety of staff or users of the services or facilities of ACEI or the public.

6. Is my personal data sent outside the European Union?

The personal data that we collect from you may be transferred to and stored outside the European Economic Area ("EEA"). It may also be processed by staff operating outside the EEA who work for one of our suppliers, in which case the third country's data protection laws will have been approved as adequate by the European Commission, or other applicable safeguards are in place as set out in the GDPR.

7. What is the legal basis for you collecting and processing my information?

Irish and EU law sets out the grounds upon which data controllers such as ACEI can rely on to lawfully process personal data.

We rely on the following grounds:

Where you have given us **consent** to the processing of your personal data for a specific purpose, for example for marketing purposes;

The processing is necessary for ACEI to fulfil our contract with you;

The processing is necessary for **compliance with a legal obligation**, for example to comply with Revenue requirements;

The processing is necessary for the purposes of the <u>legitimate interests</u> pursued by the ACEI or by a third party, except where such interests are overridden by the interests or fundamental rights and freedoms of the data subject, (especially a child). Some marketing might take place under this heading, but never to children.

The legal bases for the processing of your special category data or sensitive data (for example health data) are:

- That you have explicitly provided consent.
- Processing necessary for compliance with a legal obligation to which we are subject.

Processing necessary for archiving purposes in the public interest, scientific or historical research purposes or statistical purposes

8. What are my rights, and how do I exercise them?

As an individual, under EU law you have certain rights to apply to us to provide information or make amendments to how we process your Data. These rights apply in certain circumstances and are set out below: -

The right to access data relating to you ('access right').

The right to rectify/correct data relating to you ('right to rectification').

The right to object to processing of data relating to you ('right to object').

The right to restrict the processing of data relating to you ('right to restriction').

The right to erase/delete data relating to you (i.e., the 'right to erasure').

The right to 'port' certain data relating to you from one organisation to another ('right to data portability').

These rights are not absolute and only apply in certain circumstances. You may exercise any of the above rights by contacting us accompanied by all necessary information via: an e-mail to the Data Protection Contact at projects@acei.ie

You may lodge a complaint with your local supervisory authority with respect to our processing of your personal data. The local Supervisory Authority in Ireland is the Data Protection Commission. The website is www.dataprotection.ie

We would ask that you contact us first at <u>projects@acei.ie</u> to enable us to try to deal with the matter to your satisfaction.

Where our processing of your personal data is based on your consent to that processing, you have the right to withdraw that consent at any time but any processing that we have carried out before you withdrew your consent remains lawful.

If you are receiving marketing from us, you may opt out. If you no longer wish to be contacted for marketing purposes, please contact us as set out in this Notice to request to "opt out" of marketing.

The exercise of Data Subjects' rights as some other "interactions" requires the univocal identification of the person submitting such request as being, in fact, the Data Subject to whom such Personal Data pertains to, hence we may have to set in place a process or mechanism that allows it to document having undergone such assertive identification

9. Can I stop getting emails, text messages and other communications from you?

Yes!

If you no longer wish us to contact you in a particular way, e.g. no longer send you messages, just advise us of that and we will respect your wishes.

If you are a member of ACEI it is necessary for us to contact you from time to time in connection with services, for example to ensure your data is correct.

If you no longer wish to receive marketing communications by electronic means, just use the opt-out facility in any of our communications, OR advise us at projects@acei.ie

10. Is my personal data secure?

We are committed to protecting the security of your Data. We use a variety of security technologies and procedures to help protect your Data from unauthorised access and use. As effective as modern security practices are, no physical or electronic security system is entirely secure. We cannot guarantee the complete security of our databases, nor can we guarantee that information you supply will not be intercepted while being transmitted to us over the Internet. We will continue to revise policies and implement additional security features as new technologies become available.

The transmission of information via the internet is not completely secure and may involve the transfer of data to countries outside of the European Economic Area (EEA). This occurs typically through use of cloud solutions for web hosting, email hosting or proprietary software solutions delivered to us through the Cloud. We do not however authorise any third party to use your Data for their own purposes. Non-EEA countries may not provide an adequate level of protection in relation to processing your personal data. By submitting your data, you agree to this transfer, storing and processing.

Although we will do our best to protect your Data, we cannot guarantee the security of your Data transmitted to us. Any transmission of data is at your own risk. Once we receive your Data, we use appropriate security measures to seek to prevent unauthorised access

11. How long do you keep my personal data?

We keep your Data for as long as is necessary for the performance of the contract between you and us and to comply with our legal obligations. If you no longer want us to use your Data to provide this service to you, you can request that we erase your Data. Please note that if you request the erasure of your Data:

We may retain some of your Data as necessary for our legitimate business interests, such as fraud detection and prevention and enhancing safety.

We may retain and use your Data to the extent necessary to comply with our legal obligations. For example, we may keep some of your information for tax, legal reporting, and auditing obligations.

Because we maintain our records to protect from accidental or malicious loss and destruction, residual copies of your Data may not be removed from our backup systems for a limited period of time.

A detailed Retention Schedule has been drawn up, and if you would like further information in respect of a particular category of data relating to you, please contact us at projects@acei.ie.

12. How do I contact the Data Protection Commission?

You have the right to complain to the Data Protection Commission if you feel that we are in breach of any of your rights. Full contact details are provided below.

13. Miscellaneous

Where we process your Personal Data based only on your consent, you may withdraw your consent

You have the right to bring a complaint to a supervisory authority if you have any complaints about the processing of your Data. In Ireland the Data Protection Commission is the supervisory authority.

In circumstances where the provision of your Personal Data is a statutory or contractual requirement, or a requirement necessary to enter into a contract, we will advise you at the point of collecting your Personal Data whether the Personal Data is a required field, and the consequences of not providing the Personal Data.
