Earlier in the year, ACEI President Gerry Carty proposed that ACEI members provide financial support to the <u>Goal Watershare</u> programme in 2020. Thanks to those member firms that held events in early March to build awareness of the work of volunteers and raise funds for the initiative. A total of €2500, including an association donation, will be provided to GOAL this month.

#### **Results of Second EFCA Survey**

The European Federation of Engineering Consultancy Associations (EFCA) has published the <u>results of its second survey</u> in relation to the impact of the crisis on European consulting engineering firms. It is interesting to compare the findings from 20 countries across EFCA member associations in Europe.



## **Government Supports for SMEs**

Earlier this week, the government announced a range of <u>measures to further support</u> small and medium firms negatively affected by the current crisis. A number of welcome initiatives are planned including: a  $\leq 10,000$  restart grant for micro and small businesses, a three month commercial rates waiver, and the set-up of a  $\leq 2$  billion pandemic stabilisation and recovery fund. A commitment to local authorities has also been made to make up shortfalls in rates so that the continuation of full services to the public is provided.

#### Wind Power Overtaking Natural Gas

Electricity from wind generation sources is now overtaking natural gas as Ireland's leading provider of electricity. The SEAI announced that in the first quarter of 2020, wind turbine electricity provided 43% of total needs compared to 37% in 2019. David Connolly, CEO of the Irish Wind Energy Association, says: "It is essential, if we are to build on this success, that the next Government prioritises reforming our planning system so we can develop wind energy off our coasts, and ensure that the new wind energy guidelines enable us to build the next generation of onshore wind farms."
